

LIKE MANNA FROM HEAVEN WAS GIFT

Aged Mother of Boy Who Died Overseas Gets an Unexpected Sum

To an old woman whose feet are treading the sunset slopes of life and whose hands bear few spoils from the sunrise journey, an unexpected and unsolicited monetary gift comes like manna from heaven. That is why gray-haired Mrs. Katherine Lumpkin, mother of a boy who made the supreme sacrifice for his country, is so grateful for the compensation settlement of \$800 which the Tulsa county Red Cross recently secured for her from the government without instigation.

Mrs. Lumpkin first found her way from her humble home in West Tulsa to the Red Cross headquarters through a four months delay in the monthly insurance check of \$57.50 which meant daily bread to her husband and her. The Red Cross obtained these for her shortly and then offered to renew an effort to obtain compensation in which she had failed through another channel, and the result was a settlement of \$800 made in the shortest time ever recorded in a similar case by the county chapter. Mrs. Lumpkin was so appreciative that during the Red Cross roll call, though her funds were low, she walked all the way from West Tulsa to take out a membership. She now lives on a small farm east of the city. Her son, John William Lumpkin, was killed in France in October 1918, while in service with company K, 140th infantry.

Such incidents as this are common, though not shown in the chapter's matter-of-fact monthly reports. During the month of March 220 families were dealt with, \$396 in money loaned, 20 certificates secured in lieu of lost discharges, in addition to the office routine, according to the report just issued.
