Enclosed is a copy of the complaint S.T.O.P. submitted to the Battle Creek Human Relations Board. The city made fraudulent statements that the city had no involvement with CAP moving into the Hart Hotel---Please read 11-26-1990 letter from City Manager.

At the North Central Neighborhood Planning Council meeting, Oct. 10, 1990, members: Marty Levy; Sandy Calderone, Neighborhoods Inc. [Parent of Northcentral Neighborhood Council]; William E. Boards Jr., Ward 2 Commissioner, presented the Community Alternative Program(CAP) for their approval.

Sandy Calderone's Boss, Mike Dougherty, is head of Neighborhoods Inc. and is the former Calhoun County Drug Councilor---who supplies all the CAP/Prison for Profit schemers, illegally, with drug patients/offenders names and records.

12-21-90, one month after commissioner William Boards and the Mayor destroyed our petition and did not act on the citizens Hart Hotel/CAP complaint of 11-20-90.---Instead, William Boards attended that 12-21-90 Northcentral Neighborhood Council meeting with Robert Sharkey, the Mayor's husband's law partner and the President of CAP.

Those activities and the 8-6-90 recmmendation of CAP Inc, letter from Family & Children's Services, 182 W. VanBuren; the Calhoun County Community Corrections Advisory Board, of which the Battle Creek Chief of Police was a "secret" member---while the whole city government, aided the Mayor and her husband's law firm's scheme, in making fraudulent statements in the application for the Grant--- are unlawful violations of the Community Support Section of the Grant Application, as well as future and pending Grant Applications from the Office of Community Corrections and/or any state funds, Michigan received or will receive through the U.S. Dept. of Justice "formula Grant" under the Drug Abuse Act of 1988.

The city violated the Certified Assurances FY-1990(Drug control & System Improvement Formula Grant Program) (1),(4),(5),(6),(8): None of the applications were correct, (9): The State, through your office, failed to investigate S.T.O.P.'s prior complaints, (11): Violated the Safe Streets Act, when the city government destroyed our citizens petition. We have copies of the petition. The city government violates the Civil Rights Act (i.e) through the Public School Board meetings and the Urban League asking the Race of job applicants: Through the influence of the Mayor, the City Government has an ongoing practice whereby the local Urban League of which the MESC is rigged up to direct job applicants pertaining to race, sex and origin and passed on to potential employers: CAP violated MCLA 423.23/ Unfair Labor Practices Act.

The Mayor voted on (ETA) (JTPA) (HUD) (SBA) and other grant issues promoting family & Children's Services, Mid-Counties
