

TRIBAL GOVERNMENT EXECUTIVES MANAGEMENT COURSE

APRIL 5-7, 1993

THE WAIKIKI BEACHCOMBER HOTEL

HONOLULU, HAWAII

FOCUS:

The successful exercise of tribal sovereignty means organizational productivity in today's world. This session will give the participants a working knowledge of the management tools of Total Quality Management (TQM). It will underscore advantages and disadvantages and afford the participants the opportunity to decide what part of TQM if any is appropriate for their organization. Additionally, this session will give an update on Supreme Court Cases and Congressional Legislation. Hawaii's Senator Inouye, the Chairman of the U.S. Senate Select Committee on Indian Affairs has been invited to address Indian Congressional legislation issues. The session will also provide an opportunity to bring together American Indian, Hawaiian and South Pacific Native leaders to discuss issues of common concern.

THE TRAINING SESSION

From April 5-7, 1993, the Center will conduct a three (3) day training session in Honolulu, Hawaii for tribal government executives on management skills development. This session is designed for tribal leaders, Hawaiian and South Pacific Native leaders, tribal executives, tribal council members, tribal court judges and other personnel in charge of agencies and departments.

Total Quality Management (TQM) is a broad concept of improving organizational capability and harmony. It provides management tools that deserve the consideration of tribal leaders. This session will examine in detail the various tools of TQM, the advantages and disadvantages. For instance, the participants will learn the four stage mode of project management: definition, planning, implementation and follow-up. Participative leadership is another tool that will be explored as well as others that may be useful to tribal executives.

Additionally, this session will provide the participants with an update on Supreme Court decisions in Indian law and Congressional legislation. If you are a member of a tribal council, a department head or tribal judge, this session will have important information and materials for you. Each participant will receive a comprehensive reference manual and a certificate of completion.
