

The family of Diane King (her mother, brother and sister) was happy that the Jury found the only person accused "guilty". What Diane King's family did not know is that other Indian Tribes have complained that prisoners are taking away the Native American (Indian) livelihood. "Native Americans are now being forced to compete with Prison Contracted labor---which is 40 cents per hour---for work Native Americans had been doing."

Diane King's family should be made aware that income from prisons is the 3rd largest revenue in Michigan. Legislators from Michigan, such as Howard Wolpe, aided state legislators, such as Gilmer, Martin and Schwarz with the U.S. Bureau of Justice Data: Tax Expenditures & The Competition For Public Dollars. Howard Wolpe's data had been obtained through the Kellogg funded survey of 11 industrial states.

A month before Diane King was murdered, through the Jan. 2, 1991 Calhoun County Board of Health meeting (chaired by still another Kellogg Foundation former President, Robert Sparks), statistics of the Industrial State Survey established Michigan as the state with the most need of that \$2.7 billion newly "made" available through the Anti-Drug Abuse Act of 1986 & 88 and The Community Services Act of 1990 (PL101-610). That survey showed Michigan having a prison population of 300 per 100,000.

Diane King and other media people had been given information by S.T.O.P. on pending Michigan Prison Labor Revenue Bills, such as S.B. 251 "Local Government Revenue Sharing". The Bill that would allow Battle Creek to conduct a census to include pending New Jail/Prison Population. S.B. 8 & 9 proposes a program for housing state prisoners, create and allow funding a Community Corrections Complex Program. S.B. 8&9 includes the "Pretrial Bonding Program" and a Master Plan of Calhoun County Alternative Services (CAPS) for funding by the state office of Community Corrections (OCC). The President of CAPS is a law partner of a Kellogg Foundation Trustee, Chris Christ.

Michigan House Bill 4261 is for judges and lawyers to profit with prison contract labor through and with non-profit organizations. The so-called non-profit organization, CAPS, purchased on a land contract, through the Cereal City Development Corp., the hotel built by W.K. Kellogg which houses CAPS Prisoners. CAPS is subsidized with Kellogg Foundation influenced-- United Way sponsored Food Bank supplies and funded by state authorized Federal Grants. P.L. 101-610 Title IV sec. 401(a) (2) the Good Samaritan Food Donation Act was added to qualify Michigan, in particular Battle Creek, for donated food for the prison through the Re-inventing Government Scam.

Brad King did not get a fair trial. Conrad Sindt, Robert Sharkey and Chris Christ stood to profit more from Diane's death than Brad if the CAPS and the New Battle Creek Jail scheme continues to be pulled off. Even the Chief of Police stood to profit by shutting up Diane King.
