IF HE CAN'T PUNCH IT IN THE COMPUTER, THEN HE DOESN'T KNOW.

JANE HAS PETITIONS OUT ALL OVER AND HAS OVER 2000 SIGNATURES AND 50% OR MORE ARE CHEROKEE PEOPLE. ONE CHEROKEE LADY CAME IN WANTED TO SEE PETITION. JANE THOUGHT SHE WANTED TO SIGN ONE. SHE SAID NO I WANT ONE, THIS WAS AT 4:00 O'CLOCK FRIDAY AND SHE BROUGHT IT BACK EARLY SAT. MORNING WITH 50 NAMES OR MORE AND THIS IS JUST 1 OF MANY THAT WE HAVE GOT
