Disability - Act of June 27, 1890.

STECK SECURES OFFICE BY FOUR VOTES MARGIN

Senate Ballots in Favor of Democratic Iowa Man After Fiery Argument for Two Hours

Washington, April 11--(AP)--Senator Smith W. Brookhart, republican insurgent of Iowa, was unseated in the senate Monday in favor of Daniel F. Steck, Democrat, by a margin of four votes.

The vote, 43 to 41, came after a week of debate, which terminated in fiery argument during the last two hours of discussion when the committee which conducted the recount of ballots cast in the 1924 election was unseated and defeated.

Until the very hour of the roll call the result was in doubt but 14 republicans joined the 29 democrats in voting to unseat Brookhart overwhelming the nine democrats, 21 republicans and one farmer labor senator who supported him.

Immediately after the result was announced Steck was escorted to the rostrum by Senator Cummins, republican, Iowa, and sworn in by Vice-president Dawes. Brookhart was not present, having been absent from the chamber during the entire week of the argument.
