It ought to be understood that Mary Wyers underminded Black and Poor People, of Battle Creek, when she allowed herself to be duped into being, not only Sandy Calderone's flunky, but Wyers volunteered---She didn't make a dime on the deal---of aiding & abetting the city in holding the HUD Funds in the local Banks: First Of America, Old Kent, Comerica & Michigan National, using the old Kellogg Foundation "Matching Fund" scheme---until now---when you think the time is RIPE for you and Boards to "unshackle Us"---By "pretending" to demand those HUD Funds for Washington Heights.

According to the U.S. Bureau of Justice, arrests increased, since 1988, to 300 Imprisonments per 100,000 Population---ranking Michigan arrests & convictions the <u>highest</u> in the ll studied, Industrial States.

Therefore, would be Adventist Tourists and Relatives, visiting Michigan from other States, should be aware that Michigan, in "Competition for the Federal Dollars", have an ongoing Sweetheart Deal(PA 397,1976,MCL 331.681): Inspection of "Detention" facilities——such as the recently purchased Hart Hotel, the Michigan Health Department(s), the Circuit Court Judges, and Law Firms, such as Mayor McFee's husband's law firm, to fill up Halfway Houses. [Robert Sparks, former President of the Kellogg Foundation, mentioned in this letter P.2, Par.2, as Adventist Substance Abuse Physician, also Chairman of Calhoun County Board of Health] is responsible for both the Law and the Inspections.

We, the White majority---If this sounds racist, keep in mind that it was you who flaunted the Shackle theory--want you to understand that the white School Teachers, white school bus drivers, and the white handicapped students, who have to change busses at Ann J. Kellogg School---because Ann J. Kellogg School is the Bus Transfer Terminal for Eaton, Barry and Calhoun Counties---which include communities such as Lakeview, Bellevue, Olivet---and as far away as Marshall, Albion and Delton, as well as the white signers of that petition, have been victimized by you putting yourself in the position of being shackled.
