FROM MAC ALLEN PART CHEROKEE. I HAVE HELD A CARD
FROM THE CHEROKEE NATION FOR MANY YEARS. I AM WRITING
THIS ON BEHALF OF MY WIFE JANE ALLEN, NOT BECAUSE SHE HAS
LOST HER JOB AS TAG AGENT AT JAY. BUT FOR THE UNDERHANDED
WAY IN WHICH IT WAS HANDLED.

SEEMS LIKE WE HAVE ELECTED A NEW SENATOR RICK LITTLEFIELD,
THAT DOESN'T CARE WHAT THE PEOPLE OF DELAWARE COUNTY WANT AS
LONG AS HE PLEASES ONE OF HIS BUDDYS OR TO BETTER HIMSELF
FINANCIALLY.

SENATOR LITTLEFIELD CALLED JANE AND TOLD HER HE WAS RE-
PLACING HER BY THE FIRST OF THE YEAR. BECAUSE HE HAD A
PRIOR COMMITMENT. HE SAID YOU HAVE DONE A GOOD JOB .BUT THIS
IS SOMETHING I HAVE TO DO.

SOMETHING NEEDS TO BE DONE ABOUT THIS, IT IS UNCONSTITUTIONAL AND

& THE OKLA. TAX. COMM.

JANE HAS PETITIONS OUT ALL OVER THE COUNTY AND WE FEEL LIKE WE
HAVE OVER 2000 SIGNATURES IN THE LAST TWO WEEKS AND PROBABLY OVER
HALF OF THEM FROM THE CHEROKEE PEOPLE. SO YOU CAN SEE THAT
SENATOR RICK LITTLEFIELD DIDN'T CHECK WITH THE PEOPLE OF DELAWARE
COUNTY BEFORE HE MADE THIS STUPID MOVE.

THIS MOVE IS GOING TO HURT THE SCHOOLS IN DELAWARE COUNTY AND
THE PEOPLE FOR THE NEXT FEW YEARS.

THE TAG MONEY COMES BACK TO THE SCHOOLS IN DEL. CO.

JANE HAS WORKED HARD FOR 21 YEARS BUILDING UP THE AGENCY.

TO BETTER HER WAGES, AND TO COLLECT MORE MONEY FOR THE SCHOOLS

JANE NEEDS THE HELP OF THE PEOPLE OF DEL. CO
