

An act entitled an act making appropriations for the current and contingent expenses of the Choctaw Government for the fiscal year of 1878 & 1879.

Sec 1<sup>st</sup> Be it enacted by the General Council of the Choctaw Nation assembled, That the following sums of money are hereby appropriated out of any money in the Nat Treasury not otherwise appropriated.

1<sup>st</sup> To pay Salary of Principal Chief  
One thousand dollars \$1000.<sup>00</sup>/<sub>100</sub>

2<sup>nd</sup> To pay Salaries of National Secretary, Auditor and Treasurer \$600.<sup>00</sup>/<sub>100</sub> Each Eighteen hundred dollars

3<sup>rd</sup> To pay salaries of National Attorney and Judges of Supreme Court <sup>each</sup> \$400.<sup>00</sup>/<sub>100</sub> Sixteen hundred dollars. \$1600.<sup>00</sup>/<sub>100</sub>

4<sup>th</sup> To pay Salaries of Circuit Judges Twelve hundred and fifty dollars

5<sup>th</sup> To pay Salaries of District Chiefs Seven hundred and fifty dollars

6<sup>th</sup> To pay Salaries of District Attorneys  
five hundred and fifty dollars

7<sup>th</sup> To pay Salaries of County Judges  
two thousand four hundred dollars

8<sup>th</sup> To pay Salaries of Sheriffs two  
thousand four hundred dollars

9<sup>th</sup> To pay salaries of Circuit Clerks  
twelve hundred dollars.

10<sup>th</sup> To pay Salaries of County Clerks  
Eight hundred dollars.

11<sup>th</sup> To pay salaries of County Light house  
up to the 1<sup>st</sup> of December 1878. \$800.<sup>00</sup>  
Eight hundred dollars.

12<sup>th</sup> To pay District Light house from  
the 1<sup>st</sup> of December 1878. to close of fiscal  
year. Two hundred dollars.

13<sup>th</sup> To pay National Light house nine  
hundred and fifty dollars

14<sup>th</sup> To pay Sheriffs and deputies for  
attending Circuit Court. Two thousand  
five hundred and ninety two dollars

15<sup>th</sup> To pay jurors three thousand  
six hundred dollars,

16<sup>th</sup> Contingent fund for Principal Chief  
four hundred dollars

17<sup>th</sup> To pay salaries of Superintendent  
and district Trustees eight hundred  
dollars

18<sup>th</sup> To pay clerk of Supreme Court  
one hundred dollars.

19<sup>th</sup> To pay Sheriff for attending Supreme  
Court twenty dollars.

20<sup>th</sup> To pay Judges & clerks of Election  
four hundred & fifty dollars

21<sup>st</sup> For School purposes (General fund)  
Twenty Seven thousand five hundred  
and thirty four dollars and ninety five  
cents cents.

22<sup>nd</sup> To pay cost of claim warrants  
Three hundred dollars.

23<sup>rd</sup> To pay per diem and mileage of members of the General Council and per diem of its officers eight thousand dollars.

Sec 2. Be it further enacted that the National Auditor shall keep strictly within the limits of this appropriation, and the Secretary shall furnish him a copy of the same.
