

An act entitled an act making
appropriations for the current
and contingent expenses of the
Choctaw Government for the fiscal
year of 1878 & 1879.

Sect 1st Be it enacted by the
General Council of the Choctaw
Nation assembled. That the following
sums of money are hereby appropri-
ated out of any money in the Nat-
Treasury not otherwise appropri-
ated.

1st to pay Salary of Principal Chief
One Thousand dollars \$1000.⁰⁰

2nd To pay Salaries of National,
Secretary, Auditor and Treasurer
\$600.⁰⁰ each Eighteen hundred dollars

3rd To pay salaries of National Attorney
and judges of Supreme Court \$400.⁰⁰
each Sixteen hundred dollars. \$1600.00

4th To pay Salaries of Circuit Judges
Twelve hundred and fifty dollars.

5th To pay Salaries of District Chiefs
Seven hundred and fifty dollars.

6th To pay Salaries of District Attorneys
five hundred and fifty dollars

7th To pay Salaries of County Judges
two thousand four hundred dollars

8th To pay Salaries of Sheriffs two
thousand four hundred dollars

9th To pay salaries of Circuit Clerks
twelve hundred dollars.

10th To pay salaries of County Clerk
eight hundred dollars.

11th To pay salaries of County Lighthorse
up to the 1st of December 1878. \$800.⁰⁰
Eight hundred dollars.

12th To pay District Lighthorse from
the 1st of December 1878. to close of fiscal
year. Two hundred dollars.

13th To pay National Lighthorse nine
hundred and fifty dollars

14th To pay Sheriff and deputies for
attending circuit court. two thousand
five hundred and ninety two dollars

15th To pay jurors three thousand six hundred dollars,

16th Contingent fund for Principal City four hundred dollars.

17th To pay salaries of Superintendent and district Trustees Eight hundred dollars

18th To pay Clerk of Supreme Court one hundred dollars.

19th To pay Sheriff for attending Supreme court twenty dollars.

20th To pay Judges & Clerks of election four hundred & fifty dollars

21st For School purposes (General fund)
Twenty Seven thousand five hundred and Thirty four dollars and ninety five cents cents.

22nd To pay court of claim warrants Three hundred dollars.

23rd To pay per diem and mileage
of members of the General Council
and per diem of its officers eight-
thousand dollars.

Sect 2. Be it further enacted that
the National Auditor shall keep
strictly within the limits of this
appropriation, and the Secretary
shall furnish him a copy of the
same.

Sect. 3 That this act take effect
and be in force from and after
its passage.
