

Bill No 5

An act making requisition for certain funds under the judgment of the Court of Claims of the United States in favor of the Choctaw Nation:

Be it enacted by the General Council of the Choctaw Nation Assembled  
Sec. 1. That Campbell LeFlore the authorized Delegate of the Choctaw Nation, be and he is hereby authorized and directed for and on behalf of the Choctaw Nation to make requisition upon the proper Authorities of the United States, in such form as may be required by said authorities, for the payment to the National Treasurer of the Choctaw Nation, ~~of~~ the following sums to wit.

1<sup>st</sup> The sum of thirteen thousand dollars (\$13,000) heretofore advanced John B. Luce Attorney for the Choctaw Nation in the "Net. Proceeds Claim"

2<sup>nd</sup> Also for the sum of (\$ 38,550<sup>00</sup>/<sub>100</sub>) Thirty Eight thousand five hundred and fifty dollars, it being fifty per cent of the judgment of the Court of Claims of the United States on the

Eastern boundary claims, together with interest thereon, if interest be allowed by Congress.

3<sup>rd</sup> Also the sum of (\$ 29,724.<sup>66</sup>/<sub>100</sub>) Twenty nine thousand, seven hundred and twenty four <sup>and</sup> <sup>66</sup>/<sub>100</sub> dollars.

Back Annuities recovered under the said judgment, together with interest as above.

4<sup>th</sup> Also the sum of (\$ 1500.<sup>00</sup>/<sub>100</sub>) fifteen hundred dollars the same being the amount advanced Julius C. Folsom, one of the heirs or legatees of the Delegation of 1853. & 1854 together with interest thereon at the rate of 10% <sup>per annum</sup> to the date of payment.

5<sup>th</sup> And The sum of (\$ 1000.<sup>00</sup>/<sub>100</sub>) one thousand dollars heretofore advanced Campbell Lettore, Choctaw Delegation herein named - with interest thereon if interest be allowed.

Making a total of \$ 83,774.<sup>66</sup>/<sub>100</sub>) Eighty three thousand seven hundred

red and seventy four <sup>and 66/100</sup> dollars  
and such requisition when made  
shall be taken and accepted as,  
and is hereby declared to be such  
an requisition as is required by  
the twelfth Article of the Treaty of  
June 22. 1855.

Sec-2. That this act take ef-  
fect from and after its passage
