Assembled:-

are hereby incorporated, as a body politic, and corporate, to be known and designated as the CHOCTAW ORPHANS ASYLUM LOTTERY COMPANY. and they and their successros, and assigns shall have corporate existence for and during the term and period of thirty years from and after the passage of this act.

- 2. As principal place of business shall be at Antlers, in the Choctaw Nation, or at such other place as its board of Directors may provide,
- 3. Said Corporation is hereby authorized and empowered, to do and transact a general lottery business, under such regulations as may be prescribed by its constitution and by-laws, and for the exclusive privilege of carrying on said business in said Choctaw Nation, said Corp-oration, shall pay annually into the treasury of the Choctaw Nation, the sum of FIVE THOUSAND DOLLARS, to be used and appropriated, under the direction of the General Council of the Choctaw Nation, for the establishment of a permanent Orphans Home in said Nation. In consideration whereof, the exclusive privilege is hereby granted to said Corporation to conduct said business in said Nation, for the period aforesaid.
- 4. The business of said Corporation shall be managed and conducted by a board of \_\_\_\_\_\_\_ directors, to be elected and chosen by the stock holders of said Corporation

- The officers of said copration, shall consist of one Presdident, Two Vice-Presidents, one Secretary, and one Treasurer,
  who shall be elected from the board of directors, in the manner,
