ANACT

REMOVING THE GAINS COUNTY COURT GROUND FROM ITS PRESENT SITE

BE IT ENACTED BY THE GENERAL COUNCIL OF THE CHOCTAW NATION, ASSEMBLED:

Section 1 That the County Court grounds of Gains County, heretofore known as Hartshorn Court Ground, is hereby changed, and removed from
the present site, to Mountain Station, in Gains County, Choctaw Nation, said
site to be hereafter known as Mountain Station Court Ground, and the
County Judge of Gains County, Choctaw Nation is hereby authorized and empowered to locate the County Court House in the most suitable and convenient place in said town.

Section 2 Be it further enacted that the first term of County Court shall be held at said County Court Ground on the first Mohday in November, 1902, and thereafter.

Section 3 He it further enacted that all acts or parts of Acts coming in conflict with this Act shall be and the same is hereby repealed, and this Act shall take effect and be in force from and after its passage.
