## ANACT

AMENDING AN ACT ENTITLED "AN ACT TO INCREASE THE CONTINGENT FUND OF THE PRINCIPAL CHIEF"

WHEREAS: The ratification of the Suplementary Agreement will greatly increase the official correspondence of the Principal Chief, with the various branches of the Department of the Interior, thus necessitating a large outlay for stationary and clerical assistance; and

WHEREAS; many important matters will be continuously arising in connection with said agreement that will require the personal attention of the Principal chief away from home, thus increasing his traveling

expenses; and

WHEREAS: the present contingent fund of the principal Chief is wholly inadequate to meet these various expenses; Therefore.

BE IT ENACTED BY THE GENERAL COUNCIL OF THE CHOCTAW NATION, ASSEMBLED:

Section 1 That the act of the general Council of October 19th 1900, entitled "an act to increase the contingent fund of the Principal Chief" be and the same is be reby amended so as to increase the amount of the contingent fund of the Principal Chief from one thousand dollars to three thousand dollars.

Section 2 That this act shall take effect and be in force from and after its passage and approval.

Be it Enacted by the General Council of the Choctaw Nation Assembled:

Section 1. That the Act of the General Council of October 19, 1900, entitled "An Act to increase the contingent fund of the Principal Chief" be, and the same is hereby, amended so as to increase the amount of the contingent fund of the Principal Chief from One Thousand Dollars to Three Thousand Dollars.

Section 2. That this act shall take effect and be in force from and after its passage and approval.

Section 3. That all acts or parts of acts in conflict with this act are hereby repealed.
