Be it enacted by the General Council of the
Choctaw Nation assembled.

That the following sum of money are hereby
appropriated out of the National
Treasury to defray the regular and
necessary expenses of the Government
for the half fiscal year commencing
September 30, 1905 and ending March 4, 1906.
