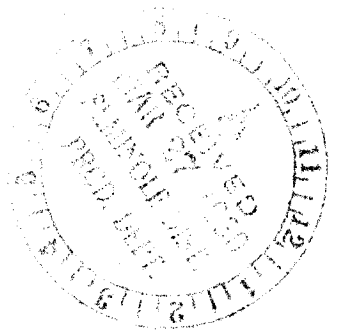


Assignment of Oil and Gas Lease

all of **their** right, title and interest of the original lessee and present owner s in and to the said lease and rights thereunder, in so far as it covers the




