HATAK HOHCHIFO HOLISSO KUT YOKOPA HE AI IMMA.

Atoka nan ittim apesa yemima nana acheffa kut isht ikono kut Chahta, Chikasha ai ibaacheffa yet hohchifo holisso kut yokopa he ya nitak vlpisa kut ikshoshke. Nan ittim apesa himona ai yakaya hokuno Chahta, Chikasha ibaachuffa putta ket hohchifo holisso kut nan ittim apesa himona yet holitopa nitak yemimuk inli ho yokopa chi miashke. Hatak, ohoyo, micha vila putta hohchifo holissa he ya asanali ket iksho hokuno moyomat yakni kashkowa isha chi hosh hohchifo yet holissot taha chi hoke. Section 28 nuta takali ilappet achukmalit otanichi hosh yakolimishke:

“Section 28. Nan ittim apesa ilappat holitopa nitak yamak fiina ka kana het okchayat ahanta tukputta ket nan ittim apesa ilapa section 27 et amia ka hohchifo et holissa he vlpisa hokma commission et holisso chashke. Nitak yamat ont ia hayokano, Chahta ai acheffa, micha yuka issa, vlla iskitini im atta putta micha tithalali putta ket holissa he keyukniet Chahta, Chikasha ahanchi kash nan immi a ik alhalayo kashke”

Nan ittim apesa himona ilappet holitopa hokmano, holisso kut peh holisso ikbano he ik holisso ketuk, micha vlla iskitini yosh Chahta, Chikasha ibaacheffa hohchifo, holisso ka asanali ket iksho yo, im osho osho nan ittim apesa himona ilappet holitopa keyu kisha kash o vlla yet anta tok; akmet nahullo yet Chahta, Chikasha asanali et iksho yo nan ittim apesa himona ilappa congress et alhopullichi keyu kisha kash o Chahta, Chikasha aienai nan vlpisa ayakaya hosh itti halali to; yohmi kia hatak ilappa chohmi kut nan ittim apesa himona yet holitopa tuk a matak pokoli chakali ittitila ho holissa he ahnit asilba hokmuk ash'e. Section 34 ilappet osh ottanichi hosh nuta ileppa takalishke:

“Section 34. Nan ittim apesa ilappat holitopa tuk a nitak pokoli chakali ai alhi ka nitak moyoma ka okloshi hopoyusa talhapi im aya tok commission to et hatak hohchifo et holisso tok i tokowa ka holissocha shke. Yohmi cha commission et hohchifo ishi ket holissa he elhpiesa tuk kia lhaofe tok putta micha nahullo et Chahta, Chikasha i nan elhpisa aiyakaya hosh nan vlpisa ilappa congress nan apesa et ik alhopulli cho kisha kash o hatak epi homma ohoyo itti halali tok putta, micha hohchifo et holisso afohkat alhtaha

tokutta im ulla vt nan ittim apesa ilappat ik holitopa kisha kash, ulla iskitini atta tukputta ka holisso chashke. Yohmi kia nitak pokoli chakali kut ont tahak mano hatak kana hohkia hohchifo holisso afohki bunnat asilha hohkia ik holisso kashke. Yakohmashke, section ilappa anumpa afohka kt Mississippi Chahta vt holisso bunnat anumpa nan asilha bohla he ako mia keyu yamma^k okano kaniohma chi ka nan ulhpisa inta hosh toba tok oke."

Atoka nan ittim apesa ai yakaya hokuno, Chahta, Chikasha ibaiachuffa yet illi hokma, yakni micha nana inla okla immi ha ai isha he i minti tuk vt falammatt okla hako imiya hoke, yohmi cha i chu^ka chuffa ya imiya keyu hoke; nan ittim apesa himona a^ko iyakaya hokuno, hata^k vt illi hokma, yakni micha nana inla okla immi yumm^k ai isha he tuk a i chuka achuffa a^ko immi toba hoke. Nana iluppvt ai alhi ka Section 22, auet iya^kaya takali iloppvt otanichi hoke.

"Section 22. Nan ittim apesa ilapvt holitopa hayo kana hut hohchifo et holisso hohchifo atakali alhtaha he mia tuk a afoket alhtaha ha yosh illi tok achini hosh haya^ka yohmi kia yakni itta kashkowa isha hetuk vt ishio kisha hosh illi hatuk ma o^kechayut ahanta kut yakni a^kaniohmi ho isha hetuk ma yamma ai isha he ai ulhpiesa tuk a i hohchifo ho yakni a apisat imashke. Yohmi cha nana inla okloshi ilapvt ai ittibahalali tuk a yumm^k ai isha he ai ulhpiesa tuk vt ai ittibafoka ho nan ulhpisa ai yakaya hosh^k i. Yohmi a ittakash^koli kt Arkansas ulhti i nan ulhpisa Mansfield et aiskachi tok o nan ulhpisa holisso chapter 49 a atakali kak^k o ai yakaya chi hosh itta kashkola shke. Yohmi cha yakni itta kashkowa ai isha he ai ulhpiesa tuk a ulhtakla nana im ai aiskiachi ulhtuka he ai ulhpiesa nan ulhpisa hosh amia no ulhtuka yosh yakni ya im apowacha ho apisash^ke. Yohmi kia nana akaniohmi na ulhtakla nana im aiskiachi a atoshpat ato ola hetuk vt ik yamohmo ho^kma, ulhtoka kia toshpat ik to salo hokma, eyu met nana inla kia akaniohmi na yakni apowacha hetuk vt i^k yohmo ho nitak vt aiona hokma commission okloshi hopoyu^ksa talhapi ittm anumpola chi hosh aya tok akosh ayamicha he et im ai ulhpiesa cha yakni ittakashkowa isha hetuk a yama^k osh im apowacha shke."

Atoka nan ittim apesa yakosh kullot mahaya hokma, Chahta, Chikasha ibaiachuffa yet hohchifo holissa chi kt tiwa na billia hoke. Yohmi hatuk o hohchifo yet nitak moyoma ka ibafoket holihinso hoke. Hata^k hohchifo yet holisso aiyukali ka, yakni micha nana inla okla immi hut chito kt ik alawot mahaya hoke. Nan isht apim ai ulhpiesa hinla kut,

hohchifo holisso hot yokopa he ako asilha hoke. Atuko nan ittim apesa himona yet nitak a belhipli hoke. September 25, 1902, iluppuk osh nitak ulhpisa hosh takali hoke, yohmi hoka Chahta, Chikasha ibaiachuffa yet moyoma ket nitak yumma nan ittim apesa himona apelat vote i kania cha, yakni mie a nana inla okla immi ai isha he ai ulhpesa tuk micha i chuka achuffa immi ai ulhpiesa tuk aienka lhakofficha he akosh ulhpesa hoke.
