An Interview with Mr. Samuel Fulton,
Kingfisher, Oklahoma.

Mr. S. F. Robinson is now eighty-eight years of age and has been a farmer without business in Kingfisher in the early years. His father and the parents elected to fight for the capital of Oklahoma Territory to be located at Kingfisher.

He did not attend the meetings at Guthrie only when called; he attended to the money and the petition that was drawn up. All the land and lots that were donated were to be sold for cash, then after everything was over all bills had to be paid and the money returned.

Kingfisher, Oklahoma Territory, September 6.

We, the undersigned mutually agree to and with each other, to form ourselves into a stock company association to be known as the Kingfisher Stock Company for the purpose of securing the location of the terri-

territory capital at Kingfisher, Oklahoma, and with that
 in view agree to pay or donate the money or property
 set opposite our respective names to be used for that
 purpose only and we do hereby severally and collectively
 make, constitute and appoint, J. K. Cunningham, Geo.
 C. Roland, J. D. Cornelius, W. Beck and J. F. Robinson
 our lawful agents to have full and exclusive control of
 all funds, and properties hereafter subscribed for the
 purposes set forth as above stated. PROVIDED: That the
 unanimous consent of all of said agents shall be obtain-
 ed to make any act of said body valid, or binding upon
 any member of this association.

All deeds, moneys and property shall be returned to
 its proper owner by said agents which has not been ex-
 pended for the purpose set forth herein, on or before
 December 1st, 1930, and the same is held in trust by said
 agents for the purpose set forth in this instrument only.

PROVIDED FURTHER that none of said property or funds
 shall be expended or used except the location of the
 Capital is secure at Kingfisher, Oklahoma Territory.
