Interview with W. N. Burgess ... Mannsville , Oklahoma

Interviewer - Jennie Selfridge Indian-Pioneer History, S-149 September 23, 1937

W. N. Burgess settled at Healdton, Indian Territory in 1891, and began work for J. W. Orms in the grocery business. He also taught school at Healdton. He had taken a teacher' course at Popular Springs, Mississippi, and teachers were hard to find in the territory. His salary was \$50.00 per month, three months out of the year. These sessions were usually in the Spring. Mr. Burgess' first school was at Bowman School House west of Healdton. He later taught at Elliott School north of town. The usual attendance was from fifteen to thirty-five pupils.

In 1898, Burgess moved to Mannaville, Indian Territory. The town was incorporated in April of that year.

Burgess was appointed United States Deputy Marshal and served under Captain John Hamer. Ben Colbert and

J. A. Porter. He also served as the first city mershal of Mannaville.

When the Federal Court was established at Marietta he moved there and served as United States Deputy until 1911. He then returned to Mannsville and served as deputy sheriff and city marshal from 1913-1929.

The first store in Mannaville stood just south of the Burgess home and was operated by B. F. Mann, who also operated the post office. Bill Payton had put in a sawnill prior to their time on the creek just below town.

Mannaville was at one time a very good inland town.

It had three churches, several stores, a good doctor,

a sawnill and gin, and a good subscription school.

The tuition for the school was from \$1.25 to \$2.50 per month depending on the number of pupils.

In 1902, the railroad came through and the town was moved one-half mile west to the present location.
