Answering question #10.

The collection has been made possible, it is thought, by the exposure to view of the contents of many mounds which extend southward from the Spiro Mounds and on up the East bank of the Poteau River to its source. That unusual exposure to view has been occasioned by the numerous floods which occurred in this area during the year 1935, which, in turn, caused erosion, not only of the banks of the river, but also of the lands lying adjacent to it. In some instances, the original level of the ground was lowered to the extent of two feet, thus bring to view many evidences of former habitation by a prehistoric people.

Then, too, the activities on the part of the State at the Spiro Mounds has had the effect of arousing interest in the discovery of antiques in the minds of the people who dwell near the Poteau River and its tributaries. The result is, that there is, at this time, a continuous hunt going on for relics by those who have no other object than financial gain. However, this does not apply to her. Harrison, who is a man of education and appreciates, fully, the significance of the discoveries in his possession.
